

**WITH POWER TO APPOINT A SUB AGENT**

KNOW ALL PEOPLE BY THESE PRESENTS that I/we

(Delmar), its offices of service being located in Canada, to be my/our true and lawful attorney to transact business on my/our behalf in all matters relating to Customs that may be transacted by a customs broker duly licensed under the Customs Act, duties under the Excise Act and any tax or levies under the Excise Tax Act including all matters relating to the accounting for and payment and refund of duties and taxes in respect of imported goods released under those Acts, at the Customs offices located throughout all ports in Canada and to execute, sign, seal, deliver and endorse for me/us and in my/our name, all Bonds, Entries, Bills of Lading, Bills of Exchange, Warehouse Receipts or other means of payment or collateral security which comes into their possession and to use same, including drawbacks and claims of any nature for reimbursement of Customs duties, sales services and excise taxes and the like, and to receive all such payments and sums of money as are now due or may hereafter become due and payable to me/us by way of rebate, refund or remission on the order of either the Canada Border Services Agency or the Canada Revenue Agency relative to the foregoing; and to endorse on my/our behalf and as my/our attorney and to deposit to and for their own account all such payments from the Government of Canada and generally to use my/our name with full binding effect whenever and wherever it may be deemed appropriate or expedient for the purpose of such business as aforesaid.

I/we, the importer named hereon, hereby grant my/our attorney full power and authority to appoint any other person to whom a license to transact business as a customs broker has been issued under the Customs Act as a sub agent to transact the aforesaid business on my/our behalf at any of the aforementioned customs offices, and to revoke any such appointment and to appoint any other person who holds such a license as a sub agent in the place of any sub agent whose appointment has been revoked, as they, my/our attorney, shall from time to time think fit.

I/we, the importer named hereon, hereby certify that to the best of my/our knowledge, all documents and/or information that will be provided to my/our aforesaid attorney by myself/ourselves or on my/our behalf, in connection with this mandate, will be true, accurate and complete.

I/we the importer named hereon, hereby agree to hold Delmar International Inc., harmless of any penalties imposed under AMPS if information provided by us or our vendors is incomplete or inaccurate in any manner.

I/we, the importer named hereon, hereby agree and covenant for myself /ourselves, my/our heirs, executors and administrators to ratify and confirm all that my/our attorney and any sub-agents appointed by them shall lawfully do on my/our behalf by virtue of these presents.
